



RSD Giveaways Terms & Conditions

Information on how to participate, Giveaways Rules and General Terms and Conditions form part of these RSD Giveaways Terms & Conditions (“Terms”). By registering or taking part in this Giveaways, all persons participating herein (the “participants”) agree to be bound by these Terms.

Giveaways Rules

Participation in the RSD Giveaways (the “Giveaways”) is free of charge and free of obligation to acquire or use any products or services through payment. The participant does not engage in any contractual or otherwise legal obligations toward RSD SA (hereafter referred to as “RSD”) or any third parties.

1. Eligibility: Giveaways is open only to those who sign up at the online Giveaways page and who are 18 as of the date of entry. The Giveaways is only open to legal residents of Australia, Belgium, Brazil, Canada, France, Germany, Ireland, Italy, New Zealand, Portugal, United Kingdom, United States, Spain, Singapore, South Africa, Switzerland, and is void where prohibited by law. 4. How to Enter: The Giveaways must be entered by submitting an entry using the online form provided on <http://www.rsd.com/customer-survey>. The entry must fulfill all requirements, as specified, and supply a valid email address to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of RSD. You may enter only once and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of RSD.

RSD shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within fifteen (15) days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.

General Terms and Conditions

1. Terms: RSD may at its sole discretion modify these terms and conditions, make prize substitutions or cancel this Giveaways without prior notice to any person. RSD expressly disclaims any warranties express or implied in connection with any prizes to the fullest extent permitted by applicable laws. The prize(s) may be subject to additional terms and conditions, and the participant agrees to comply with all terms and conditions applicable to the prizes. RSD reserves the right to vary or modify these Terms and Conditions, or disqualify any participant or winner, in such manner as RSD deems fit, without giving notice or reason, and without any liability to the such participant or winner. Limitation of Liability: By entering into this Giveaways, each participant agrees that RSD, prize suppliers, and any of their respective parent companies, subsidiaries, affiliates, directors, officers, employees and agencies (collectively, the "Released Parties") shall not be liable for injury, loss, claims or damage of any kind arising out of or in connection with participating in this Giveaways, the participants' acts omissions or negligence, and/or from the acceptance or use/misuse of the prize awarded.
